Associate Club Preview Memberships are only available to non-residents of the Tiburón community one time for 12 months. Preview Members enjoy a host of privileges as well as the use of Tiburón's Member Concierge Program.

- Year-round golf privileges for cart fee only, with 60-day advanced starting reservations
- Reciprocal golf privileges at participating Troon Golf® and Troon Privé® facilities worldwide
- Use of the members-only Fitness and Health Club
- Members-only beach transportation and lunch service
- Dining privileges at Sydney's Pub
- 20% discount on food and beverages at Tiburón Golf Club and The Ritz-Carlton Golf Resort, Naples
- 20% discount on Golf Shop merchandise at Tiburón, excluding sale items
- Preferred access to the Tiburón Golf Academy, plus discounts on all group and individual instructional programs
- Four Har-Tru® tennis courts and a heated outdoor pool with sundeck at The Ritz-Carlton® Golf Resort, Naples
- Preferred reservations at The Ritz-Carlton, Naples (The Grille Room, Main Dining Room) and preferred reservations and charging privileges at The Ritz-Carlton Golf Resort, Naples (Lemonía, Poolside Cabana Experience)
- Charging privileges at the Tiburón Golf Shop, Sydney's Pub and The Ritz-Carlton Naples Resorts.
- Private members-only locker rooms in Golf Clubhouse and golf bag storage
- Access to *The Vault*, a unique entertainment space to enjoy a state of the art sports simulator as well as pool table, darts and full bar. Member discount for private bookings

In addition, six guest passes per membership are issued to be used at any time during the calendar year allowing the cart fee price instead of the guest fee price.

Access to the swimming pool, sundeck and tennis courts at The Ritz-Carlton Golf Resort, Naples ("Golf Resort"), and the beach transportation service are being offered to Members of the Tiburón Golf Club pursuant to agreements with Troon, owners, tenants, affiliates and management of The Ritz-Carlton, Naples (the "Beach Resort") and the Golf Resort. Club Members' rights to use the facilities at the Golf Resort are subject to the Golf Resort's rules and regulations in effect from time to time and the Golf Resort may in its sole discretion prohibit any person who violates such rules and regulations from using any of such facilities. The definitive agreements provide that the Golf Resort may modify or discontinue providing hotel amenities and services to members at any time without notice if it modifies or discontinues the general availability on such amenities and services to its overnight guests. Such services may also be discontinued based on certain agreements among Troon, Club Owner and the owners, tenants, affiliates and managers of the Resort Hotel and the Beach Hotel. Please refer to the Club Membership Plan and the Club Rules for a summary of all of these provisions. All services will be charged to members at the prevailing rates than charged to hotel guests for such services. CLUB MEMBERS DO NOT HAVE THE RIGHT TO USE OR ACCESS THE SWIMMING POOL, SUNDECK, BEACH FACILITIES OR OTHER FACILITIES AT THE BEACH RESORT NOR THE RIGHT TO USE THE HEALTH CLUB FACILITIES AT THE GOLF RESORT. If the Golf Resort changes the use of the property on which the tennis courts are located, the Club Members' use of these tennis courts shall terminate, but the Club shall construct comparable tennis courts upon nearby Club property.
